Dear Families,

We have been notified that an individual in the **3/4 Aarrestad class**, in attendance Thursday, January 20<sup>th</sup> and Friday, January 21<sup>st</sup> has tested positive for COVID-19. If your child was in attendance either or both of those days, he/she is considered a close contact for 10 days from that date.

If your children feel unwell or have any COVID-like symptoms, please ensure they remain at home and call Healthline at 811. If medical attention is required, please call your health care provider or if it is an emergency requiring urgent attention call 911. As a close contact, the Saskatchewan Health Authority (SHA) strongly recommends your children take a rapid antigen self-test today and regularly. If you require rapid test kits, these can be obtained from the school so please feel free to contact us to arrange that or obtain a rapid test kit which are <u>readily available</u> from other locations as well.


The <u>Public Health Order</u> permits <u>most</u> students who are close contacts to continue to attend school <u>if they do</u> <u>not display any symptoms</u>, but if the source of that exposure is in the home, there may be restrictions. The requirements for close contacts are outlined in the graphic below. Note that a fully vaccinated person has had two doses of Covid Vaccine at least two weeks prior to the date of this letter.

**Students/staff who must self-isolate and cannot attend school** until they have met self-isolation requirements are:

- 1. Covid 19 Positive individuals;
- 2. Students who are not fully vaccinated and who are close contacts from house-hold exposure;
- 3. Staff who are not fully vaccinated and who are close contacts from any exposure; and,
- 4. Any close contacts who have symptoms.

## Saskatchewan Schools: Student Close Contact Protocol

Province-wide mask mandate applies to all students.



Students who are not fully vaccinated and who are asymptomatic close contacts from a non-household exposure are required to self-isolate at all times other than when at school/childcare or on the bus to/from school/childcare. Fully vaccinated students who are asymptomatic close contacts from any source of exposure are not required to self-isolate. More information for families can be found at the following links:

Please note that the **all classes, including the 3/4 Aarrestad class, remain open for in-person learning** for all students and that privacy regulations prevent sharing of any further details of this case. There will be no further notifications regarding this exposure event in the classroom, unless provides further direction or learning requirements change. If that occurs, we will provide further details about next steps.
